1 The parties, through their undersigned counsel and subject to the Court’s approval, stipulate as
2 follows:

3 1. WHEREAS, on June 8, 2023, Plaintiffs filed their Motion for Preliminary Approval
4 and to Direct Notice of Settlement. (ECF No. 178)

5 2. WHEREAS, on September 14, 2023, the Court granted Plaintiffs’ Motion for
6 Preliminary Approval and to Direct Notice of Settlement. (ECF No. 185). In its September 14, 2023
7 Order, the Court set the following schedule for final approval:

15 3. WHEREAS, in its September 14, 2023 Order, the Court directed Epiq Class Action &
16 Claims Solutions, Inc. (“Epiq”) to fulfill its notice duties and responsibilities. (ECF No.185 ¶ 6) The
17 Court ordered Epiq to commence disseminating notice by October 5, 2023.

18 4. WHEREAS, Epiq commenced disseminating notice by October 5, 2023.

19 5. WHEREAS, the deadline for class members to submit a claim form is December 19,
20 2023.

21 6. WHEREAS, Epiq needs additional time review, analyze, and conduct quality control
22 for claims submitted by class members to determine the number of valid claims.

23 7. WHEREAS, consistent with the Northern District of California’s Procedural Guidance
24 for Class Action Settlements, Plaintiffs seek to include the number of valid claims in their motion for
25 final settlement approval.

26 THEREFORE, IT IS HEREBY STIPULATED, subject to the Court’s approval, that:

27 1. The deadline for Plaintiffs’ Motion for Final Approval will be extended by 30 days to
28 January 18, 2024.

2. Plaintiffs’ deadline to file any additional information and the final approval hearing will also be extended by 30 days, so that the briefing and hearing schedule is:
